Minutes - On motion by Ross Smoker, seconded by Jon Payne, and Board acclamation to approve of the November 3, 2021 supervisor's meeting minutes.

## Persons Present to be Heard:

Jason Kaufman of DH\&L Fire Company reported that there were thirty-six incidents responded to this month with no significant loss. On November $23^{\text {rd }}$ the ladder truck committee will be meeting with Northumberland National Bank to work on the loan. The loan will be a government loan with an interest rate of less than three percent.
Marvin Weaver asked the Board if his Final Land Development Plans could be signed when the Letter of Credit is received. The letter of credit is supposed to be mailed, Friday, November $19^{\text {th }}$ and when it arrives the Supervisors can come in and sign the plans and agreements.
