On motion by Robert Grayston and seconded by Marvin Weaver, and carried on a 7-0 vote, the minutes of the January 25, 2021 Planning Commission meeting were approved as presented.

## New Business:

- 1) Change heading of Principal Solar to Section 702 instead of section 2
- 2) Review of Solar Ordinance Items submitted by Andrew J. Miller, Esquire with one change to implement to draft Zoning Ordinance as follows in Section 411.5C, item 4 added, "no restrictions on soil classes shall apply for Principal Solar Energy Systems."
- 3) The PC reviewed a sample Agricultural Industrial Zone from Joe Kantz.
- 4) It was discussed and decided to add the following uses to the draft zoning ordinance: To the AC zone added permitted uses will be a) Agricultural Related Warehousing or Cold Storage; b) Sales, service and storage of agricultural related vehicles and accessories and products required for farm use; c) Winery; d) Forestry; e) Feed mills, Grain Storage or Bulk Feed Storage; f) Veterinary Clinic.
- 5) After discussion it was decided to add a permitted use item to the Industrial Zone as follows: a) Meat Packaging and Processing.
- 6) Dan Kuruna's questions to the attorney general were reviewed. Jim Bathgate noted that the Planning Commission cannot add regulations that are above the state levels or the township could be sued under the "right to farm act".
- 7) Chad Shaffer's suggested lot rezoning was reviewed.
- 8) Nicole Ressler, parcel 13-02-005, located on Foxboro Road, requests that her current R1 property be rezoned to AC. The property currently boarders AC. The property has been placed on the list of suggested changes to the zoning map.
