# Penn Township Supervisor Workshop Meeting September 21, 2016

Chairman Pete DeWire called the 9.21.2016 Workshop to order 6:00 pm, followed by the Pledge of Allegiance.

**Present included:** Supervisors: Pete DeWire, Brenda Moyer and Jon Payne, Secretary/Treasurer Jacqueline Anders

Public Present: Michael Savidge, Rodney Ries, Stephen Bowers, Rick Mease, Ray Cerezo, Isaac Ramer

<u>September 7, 2016 minutes</u> - On motion by Brenda Moyer, second by Jon Payne and acclamation of board 9.7.16 Supervisors Meeting minutes were approved.

<u>Rick Mease (Selinsgrove Pool)</u>: Mease presented a letter to the board a requesting funding from the Township for \$5,000.00 to the Selinsgrove Pool for 2017. The Township has donated \$3,000.00 in the past years.

Rodney Ries and Stephen Bowers (Penn Valley Airport Authority): Bowers presented to the board Penn Valley Airport Authority proposal to build a new storage hanger in the amount of \$1.25 million. They would need all 9 Municipal Owners to be guaranteed stakeholders of \$69,500.00 to secure the USDA loan in the amount of \$625,000.00. The USDA is planning to have a question and answer meeting September 29, 2016 at 1pm.

<u>Michael Savidge</u>: Savidge presented a Hold Harmless agreement allowing for the zoning permit to be signed prior to sewer capacity for a new manufactured home at 1223 S. Market Street. **On motion by Brenda Moyer**, **second by Jon Payne and acclamation of board to approve the Savidge Hold Harmless Agreement for setting a new manufactured home at 1223 S. Market Street**.

### Reports:

Roadmaster Isaac Ramer - The used forks for the loader are out on loan and their condition can't be guaranteed. On motion by Jon Payne, second by Benda Moyer and acclamation of board to purchase new forks for the loader. Ramer will have information on grader brakes by the next meeting. Ramer ordered 20 more road cones and will mark them belonging them to the Township.

Secretary/Treasurer Jacqueline Anders - Report provided. PA DOT doesn't approve changing By-pass lights to LED lights at this time due to changing of light designs/photo metrics.

Zoning Officer Ray Cerezo: Cerezo has dealt with several complaints and has been very successful in

being able to come to verbal resolutions. Cerezo inquired what can be done when someone refused to comply to whatever reason he had been called out for. Cerezo will be attending the annual COG membership meeting 10-13-16.
