

**PENN TOWNSHIP
MINUTES
August 18, 2009**

The Penn Township Board of Supervisors held their regular meeting on Tuesday, August 18, 2009 at the Municipal Building, 228 Clifford Road, Selinsgrove, Snyder County, Pennsylvania. Vice-Chairman Todd Cox called the meeting to order at 7:00PM. Supervisors present: Todd Cox; William Moyer. Supervisor Absent: Fred Ulrich. Others present: Robin Bieber, Township Secretary. Members of the Public: Carl Kratzer.

APPROVAL OF MINUTES

The minutes of the August 4, 2009 meeting were approved as presented upon motion by Bill Moyer, seconded by Todd Cox and unanimously approved.
