

**PENN TOWNSHIP
MINUTES
July 20, 2010**

The Penn Township Board of Supervisors held their regular meeting on Tuesday, July 20, 2010 at the Municipal Building, 228 Clifford Road, Selinsgrove, Snyder County, Pennsylvania. Chairman William Moyer called the meeting to order at 7:00PM. Supervisors present: William Moyer, Fred Ulrich, Brian Wentzel. Others present: Secretary/Treasurer Robin Bieber. Members of the Public: Michael Picuch, Snyder County District Attorney.

PLEDGE OF ALLEGIANCE

APPROVAL OF MINUTES

The minutes of the July 6, 2010 meeting were approved as presented upon motion by Brian Wentzel, seconded by Fred Ulrich, and unanimously approved.

PUBLIC COMMENT

Michael Picuch introduced himself as the new Snyder County District Attorney and a Penn Township resident.

PERSONS PRESENT TO BE HEARD

REPORTS

Roadmaster Brian Wentzel provided a written report on the roadcrew's activity for the previous two weeks. Mr. Wentzel also attended an asphalt maintenance meeting and a Safe Kids to School meeting. He also gave a brief report on behalf of DH&L Fire Company. Jason Kauffman has been appointed by DCNR as the Forest Fire Warden for this area. After discussion, motion was made by Brian Wentzel, seconded by Fred Ulrich and unanimously approved, prices will be gathered for a new 'steam gennie'.

Tom Snyder, Zoning Officer, provided a written report including 51 zoning permits y-t-d. Robin Bieber, Township Secretary, had nothing to report.

Emergency Management Coordinator Fred Ulrich reported that DCNR has accepted the final submittals for the grant; the check should arrive in 6-8 weeks. The sewer pump station to be donated by ASP will not work for what is needed; cost of new tank is \$5000.00. Mr. Ulrich also reported on a few minor problems during the recent storms.

Chairman William Moyer had nothing to report.

OLD BUSINESS

Discussion was held on the proposed storage building. It was noted that the excavation will be included on the bid with the concrete walls. The plans for the building will be plotted onto existing survey documents by Larson Design Group and submitted as a Land Development plan upon motion by Fred Ulrich, seconded by Brian Wentzel and unanimously approved. It was noted that the Land Development plan will need to be reviewed by Snyder County Planning Commission as well as the Penn Township Planning Commission.
