ORDINANCE NO. 97 - 3

AN ORDINANCE OF PENN TOWNSHIP, SNYDER COUNTY, PENNSYLVANIA, AMENDING THE TOWNSHIP ORDINANCE NO. 85-2, AS AMENDED, REGARDING ROAD STANDARDS, TO REVISE EXHIBIT A TO INCLUDE A REQUIREMENT THAT ALL ROAD CUTS FOR UTILITY LINES, DRAINAGE TILES, AND THE LIKE SHALL BE BACKFILLED WITH CLEAN 2B STONE.

The Board of Supervisors of Penn Township, Snyder County, Pennsylvania enacts and ordains as follows:

- **SECTION 1.** Authority for Ordinance. This Ordinance is adopted in conformance with and pursuant to authority granted by Sections 2316 and 2317 of the Second Class Township Code (53 P.S. §§67316, 67317), and Sections 503 and 509 of the Municipalities Planning Code (53 P.S. §§10503, 10509), each as amended.
- **SECTION 2.** Amendment. Page 2 of 6, of Exhibit A as referenced in Sections 1(c) and 2(c) of Ordinances 87-2 and 93-2, which amended Ordinance No. 85-2, is amended to require "All road cuts for utility lines, drainage tiles and the like shall be backfilled with clean 2B stone.", as set forth in said Page 2 of 6 (rev 6/97) attached.
- **SECTION 3.** Affirmation. This Ordinance to amend Ordinance No. 85-2, as amended by Ordinances Nos. 87-2 and 93-2, shall affect only page 2 of 6 of Exhibit A as referenced in subsections 1(c) and 2(c) of Section Four. The remaining portions of Ordinance No. 85-2, as amended by Ordinances Nos. 87-2 and 93-2, are affirmed and shall remain in full force and effect.
- **SECTION 4.** Effective Date. This Ordinance shall be in full force and effect 5 days after its enactment.

- 1. MINIMUM 0.75% GRADE

- 3. A LEVELING OF APPROXIMATELY 25 FEET NOT EXCEEDING 4.0% SHALL BE PROVIDED AT ALL INTERSECTIONS FROM THE EDGE OF PAVEMENT OF THE INTERSECTING ROAD.
- 4. ALL ROADWAY SECTIONS EXCEEDING A 5% GRADE SHALL HAVE PAVED SHOULDERS WITH BITUMINOUS ROLLED EDGES IN ALL CUT AREAS.
