

ORDINANCE NO. 99-2

AN ORDINANCE OF PENN TOWNSHIP, SNYDER COUNTY, AMENDING ORDINANCE NO. 96-1, PARKING AND TRAFFIC REGULATIONS, ESTABLISHING 25 MILE PER HOUR SPEED LIMITS ON SUNSET DRIVE (T-450), PLEASANT DRIVE (T-452), FAIRVIEW DRIVE (T-448), CRESCENT AVENUE (T-405), BELMAR AVENUE (T-407), CHESTNUT STREET (T-409), SHERI LANE (T-401), BURGESS AVENUE (T-456), GREGORY AVENUE (T-458), HILLSIDE DRIVE (T-504), HORIZON DRIVE (T-505), QUARRY ROAD (T-484), MEADOWVIEW DRIVE (T-506), DEERFIELD COURT (T-507), SCHOOL HOUSE LANE (T-492), HIDDEN VALLEY ROAD (T-501), WEDGEWOOD DRIVE (T-508), FARM HOUSE LANE (T-510), SALEM BOULEVARD (T-509), UNIVERSAL ROAD (T-515), CALVETT PLACE (T-511), WOODLYNN DRIVE (T-512), AND CALVIN DRIVE (T-513), AND ESTABLISHING STOP INTERSECTIONS AT THE INTERSECTIONS OF FARM HOUSE LANE (T-510) AND SALEM BOULEVARD (T-509).

BE IT ORDAINED AND ENACTED by Penn Township, Snyder County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

SECTION ONE: Township Ordinance No. 96-1 is hereby amended by adding the following new subsections to Article III, Section 1 (a):

**SECTION TWO:** Township Ordinance No. 96-1 is hereby amended by adding the following new subsections to Article III, Section 2 (a):
