ORDINANCE NO. 2006 - 03

AN ORDINANCE OF PENN TOWNSHIP, SNYDER COUNTY, AMENDING ORDINANCE NO. 96-1, PARKING AND TRAFFIC REGULATIONS, ESTABLISHING 25 MILE PER HOUR SPEED LIMITS ON CERTAIN RESIDENCE DISTRICT STREETS, 35 MILE PER HOUR SPEED LIMITS ON CERTAIN URBAN DISTRICT STREETS, AND 40 MILES PER HOUR SPEED LIMIT ON SAND HILL ROAD.

BE IT ORDAINED AND ENACTED by Penn Township, Snyder County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

SECTION ONE: Township Ordinance No. 96-1 is hereby amended by adding the following new subsections to Article III, Section 1 (a):
