

AN ORDINANCE OF PENN TOWNSHIP, SNYDER COUNTY, AMENDING ORDINANCE NO. 96-1, PARKING AND TRAFFIC REGULATIONS, ESTABLISHING STOP INTERSECTIONS AT VARIOUS LOCATIONS IN THE BELMAR DEVELOPMENT AND MEADOWVIEW DEVELOPMENT.

BE IT ORDAINED AND ENACTED by Penn Township, Snyder County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

SECTION ONE: Township Ordinance No. 96-1 is hereby amended by adding the following new subsections to Article III, Section 2 (a):
