AN ORDINANCE amending Ordinance No.96-1 and Ordinance No. 2003-02, providing parking and traffic regulations, restricting parking along certain roads and streets during snow emergencies.

BE IT ENACTED AND ORDAINED, by Penn Township, Snyder County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

I. Section 6(a) of Article I of Township Ordinance No. 96-1 is hereby amended to read as follows:

“Section 6. Snow emergency parking restrictions.

(a) During a snow emergency it shall be unlawful for anyone to park a motor vehicle within the public right of way along the following:
