

PENN TOWNSHIP ORDINANCE NO. 09-02

AN ORDINANCE OF PENN TOWNSHIP, SNYDER COUNTY, PENNSYLVANIA, ESTABLISHING SERVICE CHARGE FEES FOR TAX COLLECTOR ISSUED TAX CERTIFICATIONS AS TO THE STATUS OF REAL ESTATE TAXES; SERVICE CHARGE FEES FOR TAX NOTICE COPIES TO THIRD PARTIES FOR PENN TOWNSHIP.

WHEREAS, the Penn Township Tax Collector is required and requested on occasion to certify in writing the payment status of real estate taxes levied upon the owners of Township lands; and

WHEREAS, the Penn Township Tax Collector is required and requested on occasion to supply additional copies of tax notices to third parties;

SECTION I

A. SERVICE FEE FOR REAL ESTATE PAYMENT CERTIFICATION

1. Penn Township hereby authorizes the Township Tax Collector to impose a service fee of a maximum of \$15.00 to be assessed to each person, firm or corporation requesting a certification statement of tax payment status of real estate in Penn Township.
2. The certification fee detailed in subparagraph 1, above, shall be set, from time to time, by Resolution in the event the Township determines a need to alter the fee initially established.
3. The fee for certification payable hereunder shall be paid to the Penn Township Tax Collector directly.

B. SERVICE FEE FOR TAX NOTICE COPIES TO A THIRD PARTY

1. Penn Township hereby authorizes the Township Tax Collector to impose a service fee of a maximum of \$5.00 to be assessed to each person, firm or corporation requesting a certification statement of tax payment status of real estate in Penn Township.
2. The certification fee detailed in subparagraph 1, above, shall be set, from time to time, by Resolution in the event the Township determines a need to alter the fee initially established.

3. The fee for certification payable hereunder shall be paid to the Penn Township Tax Collector directly.

SECTION II

Severability

The provisions of the Ordinance shall be severable, and if any provision hereof shall be declared unconstitutional, illegal or invalid, such decisions shall not affect the validity of any of the remaining provisions of the Ordinance. It is hereby declared as the legislative intent of the Township that this Ordinance would have been enacted as if such unconstitutional, illegal or invalid provisions had not been included herein.

SECTION III

Repealer

All Ordinances and parts of Ordinances inconsistent herewith are repealed.

SECTION IV

Effective Date


This Ordinance shall become effective five (5) days after its adoption.
